Taking action on the cost of living and providing more housing options for Tasmanians

In the next 100 days we will:

- Introduce legislation to implement our nation-leading freeze on changes to the National Construction Code, cutting red tape and helping home builders avoid unnecessary costs and delays.
- Introduce legislation to protect the rights of long-term residents in caravan parks.
- Deliver the second round of the nation-leading *Ticket to Wellbeing* program, helping to keep older Tasmanians active.
- Announce new schools to join the universal School Breakfast Club program for 2026.
- Establish a roundtable with councils to look at options for fast-tracking rezoning, specifically related to nominated housing growth areas, to reduce timeframes.
- Renew the Homes Tasmania Dashboard to increase transparency and improve usability of information.
- Alongside Anglicare, re-open Indigo Lodge in Launceston, following a well-needed renovation including new air conditioning and a new roof.
- Continue to deliver more social and affordable homes in the next 100 days, in line with our commitment to deliver 10,000 social and affordable homes by 2032.
- Transfer 34 Homes Tasmania dwellings to Wintringham, a specialist 50-and-over housing provider in Devonport, ensuring more older Tasmanians have a place to call home.
- Release new rules for consultation cutting red tape to allow licensed plumbers to self-certify work in new standalone homes to cut delays without compromising safety.
- Strengthen residential planning processes to prevent unnecessary and repeated 'clock stopping' that slows down the approval of housing for Tasmanians.
- Commence the process to amend the Tasmanian Planning Scheme to increase the allowable size of granny flats from 60m² to 90m².
- Release draft amendments for targeted consultation to the Tasmanian Planning Scheme, making it easier to develop medium-density housing right across Tasmania.
- Finalise legislation to crack down on dodgy builders and company phoenixing to protect Tasmanians building or buying a new home.

Building an even better health system

In the next 100 days we will:

- Assess Expressions of Interest received for the new TassieDoc program to provide four 100% bulk billing GP clinics, and assess the grants program to extend pharmacy operating hours.
- Begin planning for the installation of a CT scanner and associated infrastructure at the West Coast District Hospital.
- Advertise for the next recruitment tranche for the additional 51 paramedics committed.
- Invite tenders for the new 30-bed Northern Mental Health Inpatient Precinct, including a Recovery College, five-bed Short Stay Unit and a Safe Haven.
- Begin the State's new aeromedical service, delivering helicopter emergency air services, search and rescue and aerial law enforcement from January 2026.



- Release new guidelines allowing Paramedic Practitioners to prescribe certain medications.
- Notify successful recipients of a government scholarship for community pharmacists to expand their scope of practice, so they can treat 23 common health conditions across pharmacies in Tasmania.
- Finalise the process to enable Tasmanian GPs to diagnose, treat and manage ADHD for both children and adults.
- Allow appropriately credentialed pharmacists to assess, initiate and continue hormonal contraception for women from December 2025.
- Commence construction of St John's Park Intensive Residential Parenting Unit.
- Release the draft 20-year Preventative Health Strategy and first Action Plan for public consultation.
- Open applications for the next round of the Community Defibrillator Fund.
- Release the Tasmanian Nurse Practitioner Strategy and Action Plan.
- Launch the new Northern Tasmanian Eating Disorder Clinic.
- Commence construction on the expanded Royal Hobart Hospital Emergency Department Stage 2.
- Commence construction on the Midlands Multi-Purpose Health Centre Stage 2.
- Commence construction on the new multi-storey car park at the Launceston General Hospital
- Start construction on the redevelopment of the Kings Meadows Community Health Centre
- Submit the Development Application for the expanded Emergency Department and ambulance drop-off works at the North-West Regional Hospital.
- Commence construction on the Longford Ambulance Station.
- Achieve the delivery of 20,000 extra dental appointments across the State, as committed.
- Undertake an audit of Government-owned greenfield sites for the construction of new aged care and assisted living facilities in each region of the State.

Delivering our Strong Plan for a Stronger Economy

In the next 100 days we will:

- Address priority items identified through liquor licensing reform consultation including digitisation of application forms, speeding up processing and improved website guidance.
- Finalise the Government Business Charter with the TCCI to support stronger collaboration between business and government.
- Commence consultation on tranche one legislation for taxation reforms that deliver increased flexibility in land tax payment options, smoothing bill payments and reducing red tape.
- Release draft legislation and discussion paper for public consultation on a 5% levy on short-stay accommodation.
- Release the second draft of legislation to establish TasInsure following public input into a discussion paper and receipt of expert independent advice.
- Assess outcomes of Treasury Complex Repurposing EOI process and announce next steps.

- Commence consultation on draft second tranche legislative reforms to Government Business Enterprises.
- Begin the process to improve office and leasing arrangements across government for operational efficiency and to assist with Budget sustainability.
- Release the EOI for the Macquarie Point Stadium lead contractor.
- Commence procurement for site preparation and bulk earthworks at the Macquarie Point Precinct.
- Start the process of improving procurement across government for operational efficiency.
- Complete the independent evaluation of TasWater and EPA Trade Waste regulations.
- Release an updated Buy Local policy, ensuring opportunities for Tasmanian business to compete for Government business are maximised.
- Release Revised Estimates Report 2025-26 providing an update on the Government's fiscal performance.
- Finalise the consultation on the new Tasmanian Trade Strategy, ensuring stakeholder insights are incorporated into the final Framework.
- Complete the Trade and Investment Mission to the Republic of Korea and Japan, and publish a report on the mission's key findings, opportunities and anticipated outcomes for Tasmania.
- Deliver the Fresh Produce Inbound Trade Mission in January 2026, showcasing Tasmania's premium produce and strengthening commercial relationships with visiting buyers.
- Complete a full review and rewrite of the content on the Business Tasmania website to make sure our small businesses have access to current and relevant information and resources to meet their needs.
- Commence targeted consultation with key stakeholders and peak bodies on the next Small Business Growth Strategy.
- Complete consultation on the Single Start-Up Permit Discussion Paper
- Hold a forum of industry, government and TasNetworks to discuss network connections and North-West Transmission Developments.
- Release the final Clean Fuels Strategy.
- Release a Ministerial update on the 2024 Network Outage review.
- Hydro Tasmania to progress Request for Proposal for the Tarraleah Redevelopment Project.
- Open the next round of the Exploration Drilling Grant Initiative.
- Release a position paper on Tasmania's 2030 Economic Future Act - landmark legislation to streamline approvals, unlock investment and secure Tasmania's economic future.
- Table legislation to help facilitate Grange Resources underground transition.
- Announce the first phase of the audit of statutory licences, permits and approvals, to identify red tape that may be enshrined in Tasmanian statutory or regulatory contexts.
- Provide binding term sheets for new native sawlog supply arrangements through to 2040 for existing Sustainable Timber Tasmania customers.
- Sustainable Timber Tasmania to provide binding term sheets for new plantation sawlog supply arrangements to support the growth of high-quality on-island processing and maximise value from Tasmania's plantation estate.
- Allocate fee-free Construction Fund places to support training courses critical to the construction industry and housing supply sector in Tasmania.



- Launch the next Industry Partnership Program to fund projects that improve training quality and responsiveness for Tasmanian learners and businesses.
- Launch the next round of the 26TEN Workplace Grant Program to support Tasmanian workers to improve their reading, writing or maths skills.
- Announce Round 2 recipients of the On-Island Processing Grants Scheme for our forestry industry.
- Begin construction of the first live Earthworks Academy at Quercus Park, a purpose-built training site to help Tasmanians become job ready for the civil construction industry.
- Support the delivery of Hobart's Taste of Summer Festival and Launceston's Beerfest, to increase visitation to Tasmania around these events.
- Finalise new agreements with Vibestown and Rural Youth Tasmania to support the delivery of party in the Paddock at Quercus Park in February 2026, attracting visitors to Tasmania and honouring an election promise.
- Welcome the return of International Women's Cricket to Tasmania, with the Australian Women's team playing India, supported by Government events funding.
- Welcome the first-ever direct Newcastle-Hobart flights, expected to add over 26,000 airline seats for Tasmania, supported by the Government's Aviation Attraction Fund.
- Deliver Spirit Preparedness Fund grants to tourism and hospitality businesses.
- Launch the new Event Skills Training Program, delivered by the Tasmanian Hospitality and Tourism Academy – a practical, job-ready training initiative to equip Tasmanians with real-world experience across the growing events, festivals and sporting industries.
- Provide an update for industry on the progress of the new Racing Industry Funding Deed.
- Support Tasmania's creative industries to identify priority skills and design targeted training models that align with career opportunities.
- Finalise targeted program of administrative improvements to reduce red tape and deliver clearer, faster and more consistent environmental assessments for industry.
- Release the Advanced Technology Industries Strategy.
- Finalise the business case for a Digital Drivers licence.
- Release *Our Digital Future*.
- Announce reforms to the use of the landfill levy to deliver broad and impactful outcomes that support both industry innovation and improved environmental outcomes.
- Award contract for Climate Change Fine Scale projections.
- Complete the delivery of 100% Tasmanian Government primary schools using a structured approach to the teaching of literacy.
- Begin releasing the High-Quality Instructional Materials to support schools to deliver a minimum of one hour daily of structured numeracy from 2027.
- Release *Education Together* – transforming learning through collaboration, the government's 2030 education reform strategy.
- Release the Teacher Registration Act Review final report.
- Complete the \$11 million major redevelopment of Exeter High School, providing contemporary learning facilities for students and staff.

- Release the concept plan for community consultation for the South George Town Primary School major redevelopment, as part of the Government's \$188 million School Building Blitz project.
- Commence procurement for capital works at Zeehan and East Devonport primary Schools for Early Learning for Three Year Olds trial and allow for Outside School Hours Care provision.
- Consult on a draft policy to inform development of a future sardine fishery in Tasmania.
- Release a summary of the consultation on the Tasmanian Agricultural Strategy.
- Announce construction tender for the Sassafra's Wesley Vale Irrigation Scheme Augmentation.
- Release a Discussion Paper as the first stage in the development of the new Tasmanian Cat Management Plan.
- Commence consultation on the review of the Water Management (Safety of Dams) Regulations.
- Release the Consultation Summary Report for the Deer Management Policy Review Discussion Paper 2025.
- Appoint an independent adviser to the Efficiency and Productivity Unit (EPU).
- To help farmers build resilience and better prepare for future dry conditions, publish a monthly Seasonal Conditions Insight snapshot, delivering on an important election commitment.
- Begin the process of centralising Agency communications and marketing across government, to generate Budget efficiencies.
- Begin reporting Agency financials and FTE monthly.
- Begin the process of reforming Infrastructure Tasmania, to provide whole of government expertise in delivering major projects and ensuring value for taxpayers.
- Commence the development and consultation on the comprehensive, statewide Infrastructure Priority List to help guide strategic investment and support ongoing engagement with the Australian Government.
- Following the release of the Southern Tasmanian Regional Land Use Strategy for consultation, finalise arrangements with the Northern Tasmania Development Corporation and the Cradle Coast Authority for the delivery of draft northern and north-western regional land use strategies.
- Publish the updated 10-year Infrastructure Pipeline, which currently includes over \$30 billion in public and private infrastructure projects.
- Take delivery of the new gantry for the new TT-Line terminal at Berth 3 in Devonport.
- Commence construction of the Spirit of Tasmania terminal building at Berth 3 in Devonport.
- Launch tickets on sale for the new Spirit of Tasmania IV and V vessels entering service in October 2026.

Supporting our Communities

In the next 100 days we will:

- Finalise model and draft the Funding Deed for Gaming Care Officers to minimise the potential harm caused by gambling in venues.
- Open the new kitchen facility at Risdon Prison to provide greater training and rehabilitation options for offenders.
- Complete initial enabling works on the site of the new Burnie Court complex.



- Complete consultation on the Government's Family Violence Discussion paper, to improve family violence legislation.
- Release the Integrity Reform Bill for public consultation, implementing a number of recommendations of the Cox Review and Weiss Review.
- Release a Renewable Energy Community Benefits Scheme Discussion Paper, so new renewable projects can share their benefits with host communities.
- Complete the St Columba Falls track repairs to assist the visitor economy the St Helens area by delivering a new bridge, barrier fencing and visitor information booth.
- Commence the first stage of works for the Tamar Island Wetlands Boardwalk replacement project.
- Progress delivery of water and wastewater treatment upgrades and electrical services connections on Maria Island to complete the final stage of the Maria Island Critical Infrastructure Project.
- Launch the Women and Girls Sport and Recreation Strategy 2025-20032
- Achieve practical completion of the \$46.3 million Northern Suburbs Recreational Hub.
- Announce successful tenderer for the Glenorchy Sports Centre
- Announce successful recipients of the Active Tasmania Infrastructure Grants.
- Open the new St Helens Police Station.
- Begin the permanent roll-out of metal detection wands for Tasmania Police to keep Tasmanians safe from knives and other weapons, backed by legislation strengthening police powers.
- Officially open the North-West Arch Centre, providing wrap-around, trauma-informed care to victim-survivors of sexual violence.
- Deliver International women's Day small grants for events that celebrate and promote the contribution of Tasmanian women in their communities.
- Progress the Greyhound Racing Legislation Amendments (Phasing Out Reforms) Bill 2025 in Parliament to deliver the Government's commitment.
- Open the new kennel block at the Greyhounds As Pets (GAP) facility at Mangalore, which will effectively double the current capacity.
- Progress the exciting new production *Tonight at the Museum* at the Tasmanian Museum and Art Gallery.
- Open the 2025-26 Multicultural Community Festivals Small Grants program.
- Define the process for the development of the next Carers Action Plan, ensuring sector input and collaboration.
- Commence the independent and State-wide Needs Analysis for Neighbourhood Houses.
- Release the Draft Threatened Species Strategy for public consultation.
- Open the school gates, to allow public access of school ovals and sports courts, including indoor basketball courts, for community usage.
- Release the new Youth Justice Facility Draft Model of Care for consultation.
- Open applications for the next round of the Brighton place-based youth justice diversionary initiatives funding.

- Deliver the Prevention of Violence in Schools Action Plan.
- Provide a whole of government response to the independent review of Right to Information.
- Release the outcomes of consultation on the enhancement of transparency in the routine release of Ministerial diaries.
- Advertise tenders for the Stanley Highway Upgrade Project to widen the lanes, seal the shoulders and install wildlife awareness signage along a 2.8km stretch of the highway between West Inlet Track and Dovecote Road.
- Award the contract for the construction of a new Heavy Vehicle Driver Rest Area on the Bass Highway at Detention River.
- Begin demolition of the old Bridgewater Bridge lifting span, reopening the River Derwent to marine traffic.
- Complete Stage One works to upgrade a 4.72 km section of the Zeehan Highway between the Murchison Highway turnoff and Henty Main Road.
- Deliver amendments to the Road Rules 2019 to allow higher standard bicycle helmets to be sold in time for Christmas.
- Commence the Common Ticketing pilot on the Derwent Ferry Service to allow commuters to tap on and pay for their ticket using their bank card or smartphone.
- Open a market tender for the expansion of Transit Officers on buses across the State's public transport network to increase passenger comfort and safety.
- Finalise the Consultation Agreement between the Tasmanian Government and Local Government sector to ensure a robust set of principles for consultation and engagement.
- Finalise arrangements with the Local government Association of Tasmania to establish the Minister's Local Government Forum, complementing the Premier's Local Government Council.
